General Information:

- Cost is the same for all 3 days or just one day.
- All vendors must have:
 - Up-to-date **Board of Health Inspection Certificate** from your local county
 - **Vendors must complete and return Gloucester County Health Department Registration Form to the Gloucester County Health Department by June 30. Vendors will not be allowed to set up unless this permit has been obtained and is in hand at time of set up for the fair.**
 - **Vendor must apply for a fire permit from Harrison Township.**
- **It is the responsibility of the vendor to contact the county health department and the fire department to obtain the necessary permits prior to the fair.**
- **Federal Tax ID Number**
- **Certificate of Liability Insurance must also be carried - the Camden County 4-H Association , Camden County Board of Freeholders, and Gloucester County 4-H Fair Association shall be named as certificate holders. A copy must be provided to the Camden County 4-H Office prior to the fair.**
- Camden County 4-H Association reserves the right to limit the amount of vendors and items being sold. (Items which cannot be sold – cotton candy, popcorn, caramel apples slices, hot pretzels, nachos and cheese, and candy apples).
- Vendors must submit a **detailed list of the items for sale with application.**
- Vendors must supply their own equipment including tables, chairs and cover, if desired.
- **Electricity is available.**
- Set up begins each day 2 hours prior to opening time. (see Fair Hours above)
- Food Vendor spaces: \$100.00
- Application may be rejected if not completely filled out.

A confirmation will be sent **as soon as Camden County 4-H approves your application and payment has been received.** It is agreed that the fee is non-refundable after confirmation has been completed.
